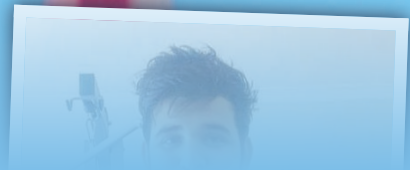

Killcare clubbie picks up rare award for extraordinary Easter holiday rescue

Churning around in all directions after copping a huge set on the head, the only thing 16-year-old lifesaver Jennifer Webb could do was hold on to the back of the rescue tube with one hand and keep her other arm around her semiconscious patient.

"We just got dumped ... I don't really like getting dumped," she said.

"One hand was on the back of the tube to make sure the clip didn't come off and the other arm was around him. As long as I was with him I knew I would be okay."

Had the brave clubbie let go in the thrashing white-water there was every chance the body she was clinging to would have been washed out to an unforgiving sea.

The teenager's incredible rescue of a 22-year-old man at Killcare has seen her nominated for a prestigious Meritorious Award at Surf Life Saving's annual gala awards night on Saturday, November 4.

The awards are given across three categories ranging from those involved in rescues where there was a moderate risk to the rescuer through to extreme risk.

Jennifer has been nominated for the latter category. Now 17, the St Joseph's Year 11 student said it was about 2pm on Easter Monday after three straight days of patrolling when she was watching a group of kids in the flagged area. Signs had been posted on the beach warning of the huge, intermittent sets rolling in sparking dangerous flash rips.

A group of young men had been playing soccer nearby when one raced out to the ball. He couldn't swim and was quickly swept out by a flash rip with another friend going to his aid.

With what onlookers would describe as "lightning speed" Jennifer grabbed a rescue tube and raced out to him some 80m from shore.

"I used the rip to my advantage," she said.

"I went past his friend because I saw someone else was going to him and when I got out there I had to reach down and pull him up by the hair."

The victim Sayed Hashimi, of Blacktown, would later say he had given up and resigned himself to dying.

Jennifer struggled to secure the tube around his body as they drifted further north when a massive set bore down on them. It drove them towards the beach where an off duty lifesaver from Sydney grabbed a board and helped her drag the semiconscious Mr Hashimi up to the sand and give him oxygen.

Jennifer, who started at Killcare SLSC as a Nipper, also competes in the inflatable rescue boat competition. She said the magnitude of the rescue only sunk in a few days later.

"I'm a lot more cautious," she said. "I watch people, looking for little things that might indicate if someone is not a strong swimmer."

Cover - Jennifer Webb was honoured not only with a Surf Life Saving Australia Meritorious Award, but also with a Pride of Australia Medal presented in a gala ceremony at the Sydney Opera House. The piece on the cover and above, from the Central Coast Express Advocate written by Richard Noone, was the first public announcement of the Meritorious Award.

Another season has come to an end with no major incidents on our beach which is a real credit to our patrolling members. This time last year I was welcoming our new tenants to the café in Latitude 33. After the dramas we had with the previous tenant we were looking forward to a better working relationship with Jay and his team. Whilst the first month was smooth sailing from there the relationship went downhill. At the time of writing I cannot go into too much detail as we are presently in a legal dispute in regards to lease and late payment. I can only reassure you all that your committee has worked tirelessly over the past 6 months on this matter to try and reach the best outcome for your club. My sincere thanks goes out to Tony Newton, Gary Lofburg and Therese Buckley for the many hours they have spent with me trying to reach a resolution to this problem.

A big thank you goes out to Kynan Hughes for stepping up and taking on the Chief Training Officer role this season. Over the past couple seasons we have not had anyone in this role and Kynan did a great job. Training is one of the hardest positions to fill especially with paperwork and organization of participants. We were able to increase our bronze and SRC members as well as increase our IRB drivers and crew and it augurs well for the future seasons.

2017/18 was a particularly good season for Killcare Nippers.

While we're immensely proud of our competitors, the primary philosophy of Nippers is 'Training Future Lifesavers'. That might mean one day pulling on the red and yellow shirt and getting under the patrol tent. It might be someone in the wider world who knows how to operate a defibrillator, do CPR or pull someone out of the water. It might be as simple as knowing where not to swim and why, thereby looking after yourself, your mates and the lifesaver who might otherwise had to have come and get you.

Our last season was the most incredible run of great conditions anyone can remember which allowed much more time for swimming and boards. That brought it's own challenges, however the upshot was that our Nippers are all much more confident and proficient in the water, where it really counts.

One of the challenges of all that water time was having enough water safety troops. You are too numerous to mention individually but on behalf of all the parents, age managers and most of all the Nippers, thank you.

While I'm thanking people, the hardworking Board and Committee of the Club under President Pete have moved mountains supporting the junior programs over the years, and none more so than last season. We're all incredibly grateful for your support.

I have the honour of heading up the programs, however it's the people under me that really make it all happen. To all our Age Managers and our Rookie Coordinator Jen Webb, we can't thank you enough.

The competitive aspect of Nippers was taken up by a relatively small number this season, but those that did compete did us proud.

Our first hit out for the season was at Umina, where Lexi Sheppard came in 2nd in the U9 Flags, Liv Melenewycz equalling that in the U10 Flags plus a 2nd in the U10 Sprint, while Lilly Hofer swept all before her winning the U12 Sprint.

Then to Terrigal where Liv backed up for another 2nd in the Flags and then teamed up with Lexi, CC Bradley & Arabella Robb for 2nd in the Beach Relay. In their first time together, Zane Foulis, Vic Houghton and Luke Ramirez picked up a 4th in the U10 Boys Beach Relay.

In January we hosted our first Nipper carnival in a very, very long time and put in a strong showing. Liv, Lexi, CC & Arabella went one better with a 1st in the Beach Relay, Lilly Hofer ran 1st with daylight 2nd in the Sprint and Raj Sharma came 2nd in the Flags and Sprint. Nathan Bradley, Ben Hofer, Ryan Sinclair & William Slater picked up 3rd in the U11 Beach Relay as did Liv Melenewycz in the Sprint and Lauren Sinclair in the U12 Flags. There were plenty of performances that just missed out on the podium as well.

Finally it was up to the Branch Championships at Shelly Beach where the U10 girls team came 2nd in the Beach Relay as did Lilly Hofer in the Sprint (after also running the 2km earlier in the morning). Then a team we haven't seen together for a while, the U12 girls of Lilly Hofer, Ruby Smith, Lily Woods and Lauren Sinclair put the band back together for a barnstorming win the Beach Relay.

The final comp for the season was the SLSNSW State Championships at Swansea Belmont. On Saturday the U10 girls gave it a red hot crack in the sprints all getting through the quarters while the relay team made it to the finals and ran 6th. On the day before however Lexi Sheppard was our sole competitor in the U9 Flags lining up against 170 other hopefuls. After several hours, she picked up only the second State medal in the Club's history with a hard won Bronze.

A special thanks has to go to our Club Coach, the illustrious JB, who patiently refined the techniques of anyone who wanted to pay attention and also to board coach Bryce Cameron who took a session every Tuesday afternoon.



Of all the achievements we have to be proud of this season, one stands out for me. For many years we have graduated our U14 groups, most with their Surf Rescue Certificate and hoped they'd come back to become 'Cadets'. This season we did things a little differently.



A dedicated group for the U15 - U18 was created, the Killcare Krakens. There are a lot of plans for the group with camps and similar activities on the cards, however the first order of business was to formally graduate them and immediately attach them to a Patrol. They even have a great t-shirt to go with it.

The Krakens we had through last season are a great bunch and there's a couple more years of really strong groups to follow so keeping them in the fold is particularly important to the future of the Club.

One of the 2018/19 Krakens was of course our 2017/18 JM Macfadyen Rookie of the Year. With such a great bunch who have pitched in with real enthusiasm, it really was a hard choice. But for overall dedication and commitment, congratulations go to Zac Webb.

1. Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009, the Australian Charities and Not-for-profits Commission Act 2012, the Charitable Fundraising Act 1991 and associated regulations. The committee has determined that the association is not a reporting entity.

Killcare Surf Life Saving Club Incorporated is an association registered under the Associations Incorporations Act 2009 and domiciled in New South Wales.

No Australian Accounting Standards, Urgent Issues Group Consensus Views or other authoritative pronouncements of the Australian Accounting Standards Board have been applied in the preparation of this financial report.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of this financial report.

Inventories

Inventories are measured at the lower of cost and net realisable value.

Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation.

Property

Freehold land and buildings are measured on the cost basis.

Plant and Equipment

Plant and equipment are measured on the cost basis.

Depreciation

All fixed assets, excluding freehold land, are depreciated on a straight line or a diminishing value basis over their useful lives of the business.

Revenue Recognition

Revenue is recognised when it is probable that the economic benefit will flow to the incorporated association and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable.

Sale of Goods

Sale of goods revenue is recognised at the point of sale, which is where the customer has taken delivery of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract.
