### President Craig Sheppard

Season 2020/21 will be remembered as the beginning of the 'new normal', where COVID-19 continued to cast its pall over everything we did. Despite a whole new set of restrictions and the necessary modifications to our entire operation, in typical SLS fashion, we got on with it. Our profound thanks first and foremost must go to our Patrollers and Captains who, despite a raft of new SOPs and a new headline responsibility of keeping an eye on new aspects of beachgoer behaviours such as social distancing and caps on numbers, never wavered in their responsibilities.

Killcare had a relatively low rescue count of 7 for the season but that was on the back of a continued focus on continually scanning and intervening, providing shoreline education to beachgoers on why they shouldn't do what they were about to do.

Our usual pre-season nervousness over patrolling numbers were soon allayed, helped in part by the SLS NSW grants specifically targeted toward keeping member retention and we thank State for the welcome funds. One of our newest Board members, Director of Education Stephen Pearson, wasted no time in ensuring our patrollers were requaled and provided no end of opportunities to enhance their qualifications. Stephen's enthusiasm has been a boon to the Club and we're incredibly grateful to have him on the team.

At the beginning of the season there was a cloud over the Nippers programs throughout the State however under the guidance of another new Board member, Director of Junior Activities Emily Buckley, we had one of our strongest seasons in memory. With the anticipated need to separate groups the decision was taken to split our groups between Killcare and Putty beaches. Despite the logistical difficulties, this is something we will continue regardless of pandemic needs if for no other reason that it provided vastly increased opportunities to get the younger groups much more confident in the water in the relative calm of Putty Beach. Bearing the bulk of the difficulties in splitting the groups were our fantastic group of Age Managers. Both the veterans and the newbies gave extra hours and effort in ensuring things ran smoothly every Sunday and the kids and the Club are so grateful to have them. Mention must also be made of the 'Killcare Krakens', our U15 & U16 group who turned up every week and repaid the debt they racked up through Nippers by putting their SRC skills to great use in providing water safety.

Killcare continued its tradition of excelling at beach sports. Kudos to David Unger, Julie-Ann Fillingham and the rest of the SLSCC team that we even had competition under incredibly stressful circumstances. Their efforts and the continued commitment of Club Coach John Bourne enabled us to rack up a slew of branch medals and 7 State medals, along with 3 of our runners - Luke Hayter, Lilly Hofer and debutante Vic Houghton - selected for the Interbranch Championship Team. Sadly Interbranch wasn't able to be held.

Core mission aside, our aim to be a central hub of the community continues to bear fruit. The Community Connect program, recognising that we are privileged to be the custodians of a Council facility that belongs to everyone, hosts Zumba, yoga, creative writing, the shower singers choir and more. Sunday Sips is ever popular and besides providing an important revenue stream brings new faces to the Club every Sunday. Work is continuing on the joint reliance project in conjunction with our sister emergency service Wagstaffe Killcare RFB and community organisations Killy Cares and the Wagstaffe to Killcare Community Association. And we were proud to host the Year 6 Graduation Party for Pretty Beach Public School in what we hope is the start of a new tradition.

I have the great privilege of heading a tireless Board and Committee. As well as new members Emily and Stephen mentioned above, Therese Buckley, Nic Urie, Garry Lofberg, Dean Robb, John Bourne, Zac Webb, Sue Fraser, Pete Bagnall, Tony Newton, Dennis Howard and Stephen Hinks were all absolutely committed to their roles and the future of the Club. Until you get involved it's hard to imagine the hours that these people put in and I am so grateful to be part of such a team. Dean, Dennis, Garry and Pete are stepping down from their roles this season and we thank them for their service.

We're grateful to so many supporters of our work; Adam Crouch MP on behalf of the NSW Government has helped us personally and financially, most recently with a \$30,000 grant which will be used to install a solar and battery system that will see us not only save a great deal of money on power bills, but will also prepare us to be able to operate 'off the grid' in emergencies.

Lucy Wicks MP on behalf of the Federal Government has also assisted with grants, most notably our fantastic new board trailer and new boards.

Despite their troubles, Central Coast Council ensured continuity in their support.

Mention needs to be made of the work of Club Admin and 'grants whisperer' Heather Pate who has put so much time into writing grant applications with incredible success.

Major sponsor Belle Property and principal Cathy Baker continue their support and have been recently joined by Roses Only. The Beach Kiosk are wonderful in so many ways and we are so lucky to have Helena and the crew so supportive. Newton's Law, our pro-bono counsel, have provided invaluable assistance and United Petroleum Empire Bay once again kept our IRB's fuelled.

I'd be lying if I said we don't have plenty of scope for improvement, however when it's all said and done 2020/21 was a very good season for Killcare. Above all it was mission accomplished - everyone who came to Killcare Beach on our watch went home again. We look forward to building on this season's foundations in 2021/22 to do better again.

Operating a surf club during a worldwide pandemic was uncharted waters for all involved. Without the support of the entire Surf Club family, from our members, local community and broader countrywide Surf Life Saving community we would not have endured as well as we have.

The club was able to gain financial support from all levels of government to help with the general day to day running costs to grants from SLS NSW for COVID support. The grants the club were able to obtain during the year were:

- SLS NSW Covid 19 Club Funding Package \$5,629.41 This was to supplement membership fees, equipment for the nippers programme, events for all members including movie & pizza nights and the nippers Christmas party.
- SLS NSW CLEG Grant \$3,952.72 purchase of essential equipment for life saving purposes.
- SLS Australia -BSEF Grant \$5,000 purchase of essential equipment including new nipper training boards.
- Community Building Partnership Grant \$3,653.10 for purchase of A/C unit in Meeting room
- Central Coast 2020 / 2021 Financial Partnership Support \$6,500

With restrictions in place for most of the year for hospitality venues we were required to be fluid in our operations for events at the Club. I would like to thank all users of the club who were very respectful of all the decisions and directives the Committee needed to make during the season. Some of the decisions were made at last minute and impacted many people. Even during these difficult times, we had great success with our Sunday Sips and as your COVID Marshall I can say that it looked like everyone enjoyed themselves when they could.

This year the operating result for ordinary activities for the club amounted to a surplus of \$25,439 which was a great result under these difficult circumstances.

All of this would not be possible without the small number of very dedicated people who make up the Killcare Surf Club committee as well as the support of Heather Pate our Administration Officer.

I would also like to thank all our Sponsors and, you the members of the club for the support in the work we all do to keep our beach safe.



### Director of Education Stephen Pearson

Firstly, a huge thank you to all patrolling members for their commitment and dedication over the season. Specific acknowledgments to our trainers and content experts – Steve McCoombe, Donny Macdonald, Scott Leivesley, Paul Ansell and Zac Webb. Thanks also to Ocean Beach and Terrigal Clubs for providing assessors and assisting in make things happen. Thank you to Michael at Branch who wrangled the paperwork and made sense of the systems. Also, to the fantastic team that supports the club, Therese, Bags, Craig, Emily, Sue, John B and the whole of the Management Committee. Last but not least Heather, who has shown extraordinary patience and support as I have stumbled along blindly. Hopefully I will be better next year if re-elected.

It goes without saying that it was a tough year. From Covid impacts to weather events we had pretty much everything thrown at us. I will highlight the positive achievements; way forward and then make a commentary of how I think we could do things better.

#### **HIGHLIGHTS**

- We have gone from one qualified trainer to three. Still not enough and the workarounds to
  ensure the paperwork gets processed when we use 'subject matter experts' for training will
  need to be tackled again next year.
- Seven new Bronze members including a Bronze award achiever who took the course at another Club. Great group and a welcome addition to the patrols. We need more.
- Requals were painfully extended and required individual attention towards the completion of the season. There was only one known regular patroller who didn't complete his Bronze requal by season end. We also had a small number of SRCs who didn't get through their elearning elements of the requal. This will be quickly addressed in the new season. As far as I am aware we compared very favourably to other Clubs.
- First Aid award status was significantly improved across the season. Firstly, we trained the new Bronzes up to a higher standard under the 'Provide First Aid' Award. It should be underlined that you don't have to have a Bronze to get on patrol if you have this award. As with every year the goal posts are moved and Bronze members can't administer oxygen now. Rather than having a moan (or perhaps in addition to the moan/groan) multiple members have taken the Advanced Resuscitation award and I feel confident each patrol will have this specialist next season.
- We added to our Silver Medallion award holders with Beach Management and Aquatic Rescue status.
- IRB Driver and Crew was tough going as the weather and Covid proved considerable road bumps. We only achieved one new Driver and three Crew.
- While we had a great outcome on the SRC award with eight new award holders. I didn't manage to get organised an SRC to BM course and this will be a priority in the new year.
- The Beach Operations App was introduced for patrols and after some glitches worked to a satisfactory level. Parts of the app are easy to use and it saves a large amount of admin time in recording patrolling hours. Other parts of the app are harder to use and manage. However, there will be no going back to paper and the app approach will increase across all situations.
- Duke of Edinburgh award was not renewed. It requires a dedicated person and also the circumstances of how the award work is undertaken has changed. This has made it less practical for ourselves to deliver for participants. A big thank you to Mandy Anderson for managing this so ably.

### **GOING FORWARD**

Recruit more Bronzes and Surf Rescue Certificate – Community Day on the 26th September, more publicity and a bigger effort to build the pool. The transition from SRC to BM is a lot easier with recent changes.

SRC to BM –The SRC stream coming through to BM is very important to the club to maintain patrols numbers and ability. Patrol Captains also need to work with our younger patrollers to make their patrols active. I know some patrols are really good at making each patrol interesting and engaging whatever the weather or patrol situation.

IRB — Working more closely with the Bronze trainees to pull them through into crew at the same time. Hopefully we can then pull them through to Driver. Training should start in Brisbane Waters not on the beach. We need two IRBs available to make the training happen without interfering with the active patrol.

First Aid —I aiming to convene a meeting pre-season with the agreement of the Club Captain for all those interested in First Aid issues. This will be wide ranging from training, to lay out of the first aid, stocking and procedures. First Aid requirements are continually moving and changing. Next year will see changes to spinal management. We need to ensure that we are well prepared to tackle whatever we have to deal with next season.

Other awards – Awareness and promotion as much as I can. I will be more pro-active in working with patrollers in suggesting awards and courses that will add value not only to the club but also their own circumstance. For example, building a path to become Lifeguards for our younger members. Always open to suggestions on how we do things better.

#### **COMMENTARY**

There are a number of roles in the Club that require significant time commitment and I would recommend that this role is undertaken by a person who can invest time between August and February. Not just on weekends but the hours that have to put in during the week on the paperwork. This investment delivers outcomes that are a huge return for the time. You can see the impact getting an award has on an individual and for the club.

For a small Club we have achieved great results due to the commitment of our trainers and members. However, I would question whether trying to maintain a full training function at a Club of our size is realistic. I personally believe that there should be better co-ordination across the Clubs and some training should be with several Clubs participating and co-ordinated by Branch. This happens now but it is ad hoc outside the Silver Medallion courses and dependent on the organising Club notifying others of training.

Maintaining a fully compliant training team would be a challenge for any size of club:

- 1) There have been only two trainers courses this season as a smaller Club we have been given special treatment and the last course we were given one of four places on the course from the Central Coast out of twenty-two who applied.
- Being a trainer requires a commitment and we are lucky to have such members. However, each year requires us to support at least three to four trainers who can make the necessary time commitment. If they were fully compliant, they would have to commit to extra courses and to requal. It really is asking a lot of a trainer to cover the extra paperwork side when their real expertise is the practical know how that delivers the results on the beach.
- There have been no 'Assessors' and 'Facilitator' courses of which I am aware of this season. We desperately need Assessors to mark trainees and pass them for awards.
- 4) To achieve Assessor or Facilitator status you need to expend significant amounts of time to qualify and also to regual.
- 5) Training requirements continually change. This year we have had to contend with major changes to BM and SRC courses.
- 6) The IT systems are in a major transition phase and paperwork requirements are involved to say the least. Knowledge of how the systems work is critical and they are in continual change.

Not only is a great to see them giving back the favour, they show the current Nippers the next path they can take not just here but on patrol.

The awards for U/6 to U/13's are fairly straightforward however when they get to U/14, Nippers are able to get their first full life saving qualification, the Surf Rescue Certificate. This requires fully qualified training and assessment. Our age groups were separated and alternated Killcare to Putty Beach. While this was brought in to keep groups sizes to a minimum it proved a boon in giving an opportunity for increased water activities particularly for our younger or less water confident groups to get in to the water for a swim or board without the pressure of the conditions of Killcare. 

### 1. Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Australian Charities and Not-for-profits Commission Act 2012*, the *Charitable Fundraising Act 1991* and associated regulations. The committee has determined that the association is not a reporting entity.

Killcare Surf Life Saving Club Incorporated is an association registered under the Associations Incorporations Act 2009 and domiciled in New South Wales.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

These are special purpose financial statements that have been prepared for the purpose of complying with the *Australian Charites and Not-for-profits Commissions Act 2012* and associated regulations. The Board have determined that the accounting policies adopted are appropriate to meet the needs of the members of the Killcare Surf Life Saving Club Limited.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the AASB and the disclosure requirements of AASB 101 'Presentation of Financial Statements'; AASB 107 'Statement of Cash Flows'; AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors'; AASB 1048 'Interpretations of Standards' as appropriate for not-for-profit oriented entities.

#### **Accounting Policies**

#### Revenue

Revenue is recognised when it is probable that the economic benefit will flow to the company and the revenue can be reliably measured.

Sale of goods

Sale of goods revenue is recognised at the point of sale, which is when the customer takes receipt of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract. Amounts disclosed as revenue are net of sales returns and discounts.

Functions and Events

Revenue from functions and events are recognised once the event is held in the Club facilities and has meet its obligations to provide a venue for the expressed purpose agreed with the parties.

Membership fees

Revenue from membership fees is recognised at time of receipt.

Grants and donations

Grant & donation income is recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

Interes

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

#### 1. Summary of Significant Accounting Policies Continued...

#### Inventories

Inventories are measured at the lower of cost and net realisable value.

#### Buildings

Buildings are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event that the carrying amount of buildings is greater than its estimated recoverable amount the decrease in value is shown in the profit and loss statement as a revaluation decrease.

#### Plant and Equipment / Surf Patrol Equipment

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount and impairment losses are recognised in the profit or loss as revaluation decreases if the impairment losses relate to the revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

#### **Depreciation**

The depreciable amount of all fixed assets, including buildings and capitalised lease assets is depreciated on a straight line or diminishing-value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease of the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

Class of Fixed Asset	Depreciation Rate
Plant and Equipment	5 - 25%
Surf Patrol & Sports Equipment	10 – 20%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These gains or losses are recognised in profit or loss in the period which they arise. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

### Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

### 1. Summary of Significant Accounting Policies Continued...

#### **Goods and Services Tax**

Revenues, expenses and assets recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST receivable from, or payable to, the ATO is included in other receivables or payables in the statement of financial position.

### Income Tax

As the company is a charitable institution in the terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

### **Trade and Other Payables**

Trade and other payables represent the liabilities for goods and services received by the company during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

### **Comparative Figures**

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

### **Critical Accounting Estimates and Judgements**

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.
