# President's Report

## Craig Sheppard

2021/22 was, in many ways, a season of unprecedented challenges however the club met each of them.

It seems a lifetime ago when Patrol 5 put the flags up in September, everyone had to be in masks and we were still under stay at home orders to the point where we had to get special permission for some of our Sydney-based crew to even come up the Coast to do patrol. It was an odd time where doing patrol, spending the whole day on the beach - while everyone else had to come, exercise and leave - and being able to be with people you didn't live with seemed like a special gift!

When restrictions eased, some terrific conditions and travel bans meant bumper crowds beyond what we're used to, but all patrols managed them brilliantly and they are to be commended for their efforts.

These brilliant conditions were of course followed by apocalyptic weather - massive seas, record-breaking rain and flooding that deluged our beach and waters with pollution and debris the likes we've never seen. Killcare, along with all Central Coast beaches, was closed for weeks on end and even when the weather eased the pollution and debris created ongoing hazards. No matter what was thrown at us, we fulfilled our promise and were ready to react as best we could, keeping the safety and well-being of our patrollers top of mind.

Through it all there were some terrific highlights.

Always top of the list, our core mission is to make sure that everyone who comes to Killcare Beach on our watch goes home again and we can tick that one off. 12 rescues, and 649 documented preventative actions. Preventatives can seem trivial at the time but having a word to someone before they get into strife is much better than chalking them up in the rescue column, or worse. If patrollers were ever to wonder what they're doing here, there's at least 661 people who owe you, ranging from stopping them from having a bad day to their literal lives.

We are of course immensely grateful to everyone who patrols, but when it comes to our central purpose there are few people who put their hands up just that little bit higher. Firstly our Directors of Lifesaving Matt Hayter and Luke Hayter who put so much time into getting things organised and keeping them that way and this season in particular they've spent an enormous number of hours plugging the holes that covid and other issues left. Then of course our Patrol Captains who take on the extra responsibility of being in charge of patrols and deciding whether to make the vow that we do when we put the flags up. To Dean Maddick, Troy Felice, Tony Newton, Nic Urie, Garry Lofberg, Tom Buckley, Andrew Stevenson, Steve McCoombe and Emily Buckley, a particular thanks.

We also had the pleasure of inducting two new Life Members this season; Nic Urie joined the club in 2004, is a Patrol Captain, IRB Driver and Vice President (House). He continues to put enormous amounts of time into the club on so many levels. Pete 'Bags' Bagnell joined Killcare after moving from WA and went on to be Patrol Captain, IRB Driver, Club Captain and President, guiding the club through some difficult times. He was also a very active and keen boatie. Bags has retired up the coast but will always be part of Killcare's DNA.

Nippers under the leadership of Emily Buckley, ran with lots of QR codes and disinfectant and largely thanks to Scott Leivesley, Deb Scarlett and Debs Haig, we graduated 23 new SRC's - the largest group of Rookies in anyone's memory this club has seen. It deserves special recognition that Deb Scarlett has not just managed but kept this large and pretty rowdy bunch from U6's and as their Nipper journey ends so does hers as an Age Manager however we hope we can keep her involved in some capacity.

Congratulations to the winner of the JM Macfadyen Rookie of the year, Alex McCoombe-Lopez who aced every aspect of his SRC assessment and, even before then, had become and continues to be a valuable member of Patrol 8.

Our Director of Education, Stephen Pearson, did a truly magnificent job in a very complex landscape. Amongst our bumper crop of SRC's, new bronzies, 5 new IRB drivers, 8 new crew, 3 new SMBM, and 1 new SMAR, he worked incredibly hard to ensure everyone was requalified under the new rules. Killcare is aiming to build up our own stock of trainers and assessors but in the meantime we are reliant on our friends from neighbouring clubs to assist. Particular thanks for the incredible amount of time they've offered us this season go to Tim Pitollo from Terrigal SLSC and Jason Smith from Ocean Beach SLSC.

To a large degree, 'cancelled' was the theme of the sports season, with events ranging from States, through Interbranch to our own club champs unable to be run due to either the pandemic or the weather. One particular highlight though was one of our new masters, Tony Brown, in his first ever carnival at Branch Champs, picking up the gold, silver and bronze set on the beach. We look forward to a reinvigorated competitive season in 22/23.

Beyond the core mission and the fun that goes along with it, we are of course required to run a substantial business with more regulatory oversight than most. Congratulations to our admin team of Heather Pate and Director of Finance Therese Buckley for their work through the entire season but particularly on achieving a clean bill of health in the SLSNSW audit and an outstanding financial result for the year.

Heather has sadly tendered her resignation. With the nest about to be emptied her and husband Bill are planning some extensive travel. While sad for the club, we are extremely happy for them. 'Grateful' simply does not do it justice; Heather has been a boon to the Club over the last four and a half years, guiding the acquisition of hundreds of thousands of dollars worth of grants, tireless work on all areas of administration and lifting the profile and frequency of functions, itself a significant income generator. Beyond all that Heather is simply a joy to work with. She will be greatly missed and on behalf of everyone at the club we wish the Pates only the very best for the future.

Mention must also be made of our incoming Director of Administration. This is a hugely complex and responsible position that Jill Williams has taken to with aplomb. Nic Urie is a constant presence around the club keeping everything running and the alarms quiet and our new Director of Member Services Jane Leivesley is bringing a new energy to getting people involved.

I would also like to thank Tony Newton for his dedication in assisting us with legal matters during the season. His expertise and pro bono time, on top of his Patrol Captain duties, is very much appreciated.

With our AGM around the corner our long-time Junior Club Captain Zac Webb will be stepping down. Zac will continue in the Gear Steward role however through his time as JCC he has grown into exactly the asset surf needs - knowledgeable, hugely capable not just on the administrative side but as a life saver having also achieved Bronze and Silver Medallions as IRB Driver, Aquatic Rescue and Beach Management. Thank you Zac.

Running a surf club requires substantial amounts of money and we are grateful for the financial support of our major sponsor Belle Property Killcare. The support of our local, state and federal governments along with SLSCC, SLSNSW and SLSA has also been integral to our continued operation.

We're looking forward to a terrific 91st season.

## Director of Finance Therese Buckley

The 2021/2022 season opening was, to say the least, very different from anything else we had experienced before with most of NSW in the middle of a COVID lockdown.

Once again our members, the broader surf life saving community and all involved stepped up to do what they had to do in very difficult circumstances. We were also eligible for further COVID support grants from the NSW government to help ease the financial burden.

The club continued to take the opportunity to improve our resources and facilities during this time through financial support from all levels of government for specific projects. The grants the club were able to obtain during the year were:

- Central Coast Council 2021 /2022 Financial Partnership Support - \$6,500
- Central Coast Council Community Day Grant - \$2,818
- Dept of Industry Grant - Gear Shed Storage Project \$6,555
- Office of Sport - NSW - Solar & Battery Project \$27,000
- SLS NSW COVID Sport Distribution \$1,000
- SLS NSW BSEF 2021/2022 Grant - New IRB Purchase - \$15,000
- SLS NSW Silver Salties Grant \$500
- NSW Government Small Business COVID Support - \$22,5000

The social season started off slowly due to the COVID restrictions however once the new year rolled around members and the local community were ready to party. We had a very busy functions calendar and I would like to thank all our bar staff, committee members and Heather for the wonderful work done to ensure our guests' day was as perfect as possible.

The operating result for ordinary activities for the club amounted to a surplus of \$96,742 which was a great result under these difficult circumstances.

All of this would not be possible without the group of very dedicated people who make up the Killcare Surf Club committee as well as the support of Heather Pate our Administration Officer.

I would also like to thank all our sponsors and you, the members of the club for your support in the work we all do to keep our beach safe.

## Director of Administration Jill Williams

The 2021/22 season saw the Surf Club Administration kept busy as we dealt with the impacts of ongoing Covid restrictions then increased demand as everything reopened.

The Club was fortunate to successfully receive grant funding from multiple sources to support increasing operational costs and replace and enhance the Club facilities. This included:

- New large storage cabinets to house training, lifesaving, nipper and patrol uniforms; steel IRB motor bracket; steel gym equipment storage. Thank you to the Australian Government Stronger Communities Grant, Lucy Wicks Federal Member for Robertson for funding \$6,500.
- Solar panel and battery back-up grant funding of \$27,000 from NSW Government Surf Club Facility Grant, Adam Crouch Member for Terrigal. A further \$15,000 was used from a previous solar grant. The total solution included a 19.8 KW solar system including 60 Australian made panels, 3 on/off grid inverters and 4 back up batteries. Thank you to BMC Energy for a smooth implementation of this project to the value of \$45,450.
- Central Coast Council provided funding of \$2,818 towards costs associated with running our Emergency Services Community Open Day. This included the cost of purchasing demonstration major tourniquet and AED equipment, signage and marketing material. Unfortunately this event was impacted by Covid restriction and has been postponed until September 2022.
- The Australian Government providing funding through the Beach Safety Equipment Funding (BSEF) \$15,000
- SLSNSW provided \$2,500 through the Sun safety grant funding.
- Club Lifesaving Equipment Grant (CLEG) \$4,300
- The Club successfully completed the required Compliance resulting in a grant of \$6,100 from SLS NSW.

We also acknowledge our major sponsor, Belle Property, who's ongoing funding and community support provides much needed funds for lifesaving equipment and operations.

Functions were again impacted by Covid Restrictions with many events needing to be rescheduled multiple times. The commencement of Sunday Sips also had a delayed start, but ran very successfully once up and running. Thank you to Alison Bishop from Pachamama and Dan Humphries from Dan's Jerk Joint who turned up every week to provide their amazing food. Once restrictions were lifted, the Club was extremely busy as postponed and new weddings, parties, anniversaries, life celebrations, and Sunday sips resulted in over 60 bar shifts. A huge thank you to our fantastic team of RSA qualified bar staff who made this possible.

Our Community Connect Program successfully continued with our regular teachers plus new classes added including Yoga, Zumba, Tai Chi, and Pilates. This ongoing program offers local members of our Community to utilise the surf club facilities. The Surf Club facilities were also frequently used by local Community groups including Killy Cares and the Pretty Beach School.

Enquiries for nipper and community registrations increased with assistance provided where ongoing difficulties were experienced with the online registration system.

Thank you to the Board and Committee for their unwavering support and we look forward to working together as we move into the next season.

# Director of Education Stephen Pearson

I think it is important to start my report with my appreciation and thanks to the great group of people who work so hard to keep the Club delivering on its mission.

Thanks to all the patrollers who turn up and dedicate their time on patrol.

To the trainers who put in the extra hours above their patrol duties – Richard Taylor, Scott Leivesley and Donny Macdonald. To the great support we receive from other Clubs and especially Jason Smith from Ocean Beach SLSC and Tim Pittolo from Terrigal SLSC. Michael Hyslop at Branch is always there for any question or issue.

To the whole of the Management Committee of the Club who strive to make the Club function, perform its obligations and deliver a community club for all to participate in. A big thank you to Heather as she has unfailingly supported me in my role in a very difficult year.

Last year was tough but this year was a whole level above. We have battled COVID restrictions and the worst weather and pollution I have seen at Killcare in over 30 years. How we managed to get any training completed is testament to the persistent and commitment of trainees and trainers alike.

## HIGHLIGHTS

- Eight new Bronze members ranging in age from 15 to 76 years old. You are never too old to become a Bronzie.
- 22 New SRCs – An absolutely stellar effort from Scott Leivesley and his team. The paperwork alone exceeded that length of a patrol board.
- Requals were hard and again required individual attention to achieve completion. There was only one known regular patroller who didn't complete his Bronze requal.
- First Aid award status was significantly improved across the season building on the improvements from 2021. Firstly, the merits of training our new Bronzes up to a higher standard under the 'Provide First Aid' Award was again proven. We now have an advanced resuscitation award holder on each Patrol up from one in 2021.
- We are getting non-Bronze holders onto Patrol with First Aid skills. You don't have to swim to be on patrol.
- We added to our Silver Medallion award holders with a good response on the Beach Management award courses held early in the season.
- IRB Driver and Crew was really tough going as the weather and Covid proved considerable road bumps. We only achieved 6 new Drivers and 8 Crew.
- The Beach Operations App is now fully bedded in. Some features are good but it is still very buggy.
- The SLSA's over 65 program 'Silver Salties' has started up and we are the first Club on the Central Coast to join up. Over time this could prove to be a valuable source of members and patrollers.
- The addition of the winter swimmers 'Frigid Digits' as a club within the club. There are over 50 members including 30 who would not otherwise be in the Club as part of the Silver Salties program.

## GOING FORWARD

Recruit more Bronzes and Surf Rescue Certificate – The Community Day this season was cancelled twice due to COVID. Hopefully we can kick the new season off with a great day in September. We are not replacing our losses in patrollers and really need 12 plus new bronzies this year

Requals – This has to be done collectively. Even in my short period as D of Ed it has grown exponentially. The level and effort required is a turn off for many patrollers as the requirements increase each year.

SRC to BM –The SRC stream coming through to BM is very important to the club to maintain patrols numbers and ability. Patrol Captains also need to work with our younger patrollers to make their patrols active. I know some patrols are really good at making each patrol interesting and engaging whatever the weather or patrol situation.

IRB – We are struggling for crew and drivers despite numbers being up this year and we have to recognise that we will be dependent on Oceans Beach and other Clubs for training for the foreseeable future.

First Aid – First Aid requirements are continually moving and changing. Advanced Resuscitation is changing with a move to a new award in 2024 and this may have a big impact on our Patrols.

Other awards and training – There are potential opportunities to build other training options and always happy to take on suggestions.

## COMMENTARY

For a small Club we have achieved great results due to the commitment of our trainers and members.

As with last year, I would question whether trying to maintain a full training function at a Club of our size is realistic. I personally believe that there should be better co-ordination across the Clubs and training should have several Clubs participating and co-ordinated by Branch. This is happening now informally with the IRB training but it is ad hoc outside the Silver Medallion courses and dependent on the organising Club notifying others of training.

Training compliance and requirements are continually changing. The paperwork requirements are particularly onerous. To keep ahead of the changes in awards is a significant effort. SLSA do not appear to understand the impact of these continual changes have on our patrollers. We are volunteers and maintaining capability is very time consuming.

Finishing on a positive note I have seen several rescues this year and I am absolutely sure that we would have seen fatalities without the intervention of our dedicated and brave patrollers. If I have made even the smallest of contributions to skilling up or supporting those patrollers I have been amply rewarded.

## Junior Club Captain Zac Webb

While most of us began the season with 6 members on our patrols, in line with the Covid policies from SLSNSW, my season began on a zoom call with a number of usual suspects. Our task this year was much bigger than any previous years. Get 20 Nippers through their Surf Rescue Certificate and then into the senior ranks of the club and as a result double the numbers within the Krakens program.

It appears that we have had an extremely impressive year for upskilling within 13 – 18-year-old age group that makes up the Krakens. 5 - Silver Medallion IRB Drivers, 2 - Silver Medallion Beach Management, 1 – IRB Crew Certificate, 5 – Bronze Medallion and First Aid.

Our Krakens also did a fantastic job of assisting with club events, including the Bouddi Coastal Run, the Junior Branch Carnival, and the inaugural Krakens Boat + Pizza Night.

Attendance at Branch programs was at an all time high, with at least two participants for each of the programs. There were lots of parents, grandparents and carers who chipped in all over the place to make the season a success; please know that you were seen and that we're all very grateful for your assistance.

Of course our greatest thanks is reserved for our Age Managers who come down every week to share their enthusiasm for the program. Nippers is literally impossible without you all.

COVID threw up challenges throughout the season; from the relatively simple things like checking

in and keeping distance through to the continued use of Putty Beach as a regular site. Our age groups were separated and alternated Killcare to Putty Beach. While this was brought in to keep groups sizes to a minimum it proved a boon in giving an opportunity for increased water activities particularly for our younger or less water confident groups to get in to the water for a swim or board without the pressure of the conditions of Killcare. **1. Summary of Significant Accounting Policies**

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Act 2009*, the *Australian Charities and Not-for-profits Commission Act 2012*, the *Charitable Fundraising Act 1991* and associated regulations. The committee has determined that the association is not a reporting entity.

Killcare Surf Life Saving Club Incorporated is an association registered under the *Associations Incorporations Act 2009* and domiciled in New South Wales.

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

These are special purpose financial statements that have been prepared for the purpose of complying with the *Australian Charities and Not-for-profits Commissions Act 2012* and associated regulations. The Executive Committee have determined that the accounting policies adopted are appropriate to meet the needs of the members of the Killcare Surf Life Saving Club Limited.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the AASB and the disclosure requirements of AASB 101 'Presentation of Financial Statements'; AASB 107 'Statement of Cash Flows'; AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors'; AASB 1048 'Interpretations of Standards'; AASB 1054 'Australian Additional Disclosures' as appropriate for not-for-profit oriented entities.

**Accounting Policies**

**Revenue**

Revenue is recognised when it is probable that the economic benefit will flow to the Association and the revenue can be reliably measured.

*Sale of goods*

Sale of goods revenue is recognised at the point of sale, which is when the customer takes receipt of the goods, the risks and rewards are transferred to the customer and there is a valid sales contract. Amounts disclosed as revenue are net of sales returns and discounts.

*Functions and Events*

Revenue from functions and events are recognised once the event is held in the Club facilities and has met its obligations to provide a venue for the expressed purpose agreed with the parties. The receipts and deposits take are treated as deferring functions and events revenue liabilities until the events is completed.

*Membership fees*

Revenue from membership fees is recognised at time of receipt.

*Grants and donations*

Grant & donation income is recognised as revenue when received unless they are designated for a specific purpose, where they are carried forward as prepaid income on the balance sheet.

*Interest*

Interest revenue is recognised using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

All revenue is stated net of the amount of goods and services tax (GST).

**Inventories**

Inventories are measured at the lower of cost and net realisable value.

**Plant and Equipment / Surf Patrol Equipment**

Plant and equipment are measured on the cost basis and are therefore carried at cost less accumulated depreciation and any accumulated impairment losses. In the event the carrying amount of plant and equipment is greater than its estimated recoverable amount and impairment losses are recognised in the profit or loss as revaluation decreases if the impairment losses relate to the revalued asset. A formal assessment of recoverable amount is made when impairment indicators are present.

**Depreciation**

The depreciable amount of all fixed assets, including buildings and capitalised lease assets is depreciated on a straight line or diminishing-value basis over the asset's useful life to the entity commencing from the time the asset is held ready for use. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

The depreciation rates used for each class of depreciable asset are:

<b>Class of Fixed Asset</b>	<b>Depreciation Rate</b>
Plant and Equipment	5 - 25%
Surf Patrol & Sports Equipment	10 – 20%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at end of each reporting period.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These gains or losses are recognised in profit or loss in the period which they arise. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

**Cash and Cash Equivalents**

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

**Goods and Services Tax**

Revenues, expenses and assets recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included in other receivables or payables in the statement of financial position.

**Income Tax**

As the Association is a charitable institution in the terms of subsection 50-5 of the Income Tax Assessment Act 1997, as amended, it is exempt from paying income tax.

**Trade and Other Payables**

Trade and other payables represent the liabilities for goods and services received by the association during the reporting period that remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

**Comparative Figures**

Where required by Accounting Standards, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

**Critical Accounting Estimates and Judgements**

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that may have a financial impact on the entity and that are believed to be reasonable under the circumstances.
